## EXPECTATIONS OF BOARD MEMBERS

- Must hold active membership in CPRS for a minimum of one year
- Candidates must agree to make every effort to attend CPRS-sponsored events, including Board meetings, the AGM, events, etc.
  - Agree to involvement as chair of a CPRS Calgary committee:
  - Term of Office: two years, with the exception of President-elect, which is a three-year term - serving as President-elect, President and Past-President
